## SHARING CARE WITH PARENTS - AGREEMENT FORM

## School

- 1. Every possible effort will be make to keep your child safe and happy always.
- 2. Your child will be stimulated through an environment designed to encourage his/her development.
- 3. The school will be open from 9.00a.m. 12. noon. Monday to Friday.12.30pm-3.30pm
- 4. The cost per month is 145 euro for 2 days.

The cost per month is 205 euro for 3 days.

The cost per month is 260 euro for 4 days.

The cost per month is 140 euro for 2 afternoons 12.30 - 3.30pm.

## \*\* Important note 5

5. The school will normally take the same holidays as the primary schools.

The fees have been calculated over a ten-month period.

A further three weeks will be made available in July of each year but this will be organised separately during the year and will depend on demand. The list of holidays will be issued at the start of the school year.

- 6. A safe and hygienic environment for the child will be provided.
- 7. Safe activities will be provided outside in the garden.
- 8. The school will always have a temperature warm or cool enough for your child's comfort.
- 9. The Policy and Procedure Documents are available for inspection on request.

## PARENTS

- 1. Will pay one month in advance at the current rate. Once your child has started school the fees will be payable whether the child is in school or not as the place is booked for him/her (see fees listed above)
- 2. Will not bring the child when he/she has a fever, gastric upset or any other contagious disease.
- 3. Will observe the opening and closing times carefully.
- 4 Will mark the names on the children's clothing. If, however the names are not put on, the parent will accept responsibility. Every care will however be taken for the children's clothing during their time at school.
- 5. Will give the child a light healthy lunch for their break. Please avoid Tayto crisps, similar snacks, chocolate, and sweets. <u>Chewing gum is not allowed</u>. Healthy lunches are preferred and strongly recommended by the Health Board Inspection team.
- 6. Parents will give four weeks' notice in writing when the child is leaving before the end of the term
- 7. A deposit of 50euro will be paid on the booking of your child into the school. <u>Please return this with your forms.</u> This will be deducted from the last two weeks of your child's fees when he/she leaves the school at the end of the term. In the case of the free pre-school scheme the deposit will be returned when the ECCE payment comes through. The booking deposit is non-refundable if the place is not taken or the child leaves before the end of term.
- 8. Parents agree for their email address(es) to be used for communication by Starting Point Montessori School. Starting Point Montessori school will not pass on contact details to any third party without prior permission from parents.
